

Snapshot

San Mateo County is situated below San Francisco along the Pacific Coast in the heart of Silicon Valley. It is a county of coastal beaches and tidelands.

In 2000, the median age was 3.5 years older than California. One of every 8 people was 65+ and one in 59 was 85+. More than one in 5 adults was 65+ or disabled.

Workforce

Unemployment was low 2.8% (2001). There were an estimated 831 direct care nursing staff needed in facilities (2000). County has IHSS Public Authority. Average hourly wages (2001):

Medi-Cal

In San Mateo county one in every 18 people was eligible for Medi-Cal. One in every 67 persons in the county was 65+ and on Medi-Cal.

San Mateo is one of 8 counties with a County Organized Health System (COHS)--Health Plan of San Mateo--which serves 91% of the county's Medi-Cal recipients, including seniors.

Housing

The median home price was \$521,542 (2001). Compared to California, housing vacancy rates in 2000 were lower for both homeowners at 0.5% and for rentals at 1.8%.

San Mateo had more households with individuals 65+ (20.5%) and 65+ living alone (8.4%) than California. Of those 65+, one in 2.9 was living alone (34.1%).

LTCIPP: State grant funds from DHS were received for planning and development of a system to coordinate and integrate services for seniors and those with disabilities.


Transportation

Demographic Trends

In the last decade, San Mateo County's population grew at a pace slower than California. There was also slower growth in those 65+ but a faster growth of those 85+.

In 2000, San Mateo had 50% non-Whites, while California had 53% non-Whites. One of every 5 persons was Hispanic/Latino; one in 5 was Asian; one in 29 was Black/African American; and one in every 30 persons was multi-racial. Looking at age and ethnicity: one in 11 persons was 65+/White; one in 53 was 65+/Asian; and one in 88 was 65+/Hispanic/Latino.

The median household income was \$23,300 more than California's, with few people living below the poverty level--one in 17.

Emerging Long Term Care Issues

- ~ More than one in 5 adults was 65+ or disabled.
- ~ Fewer younger disabled than many counties.
- ~ Lowest poverty level in state, with few seniors living in poverty.
- ~ Income level was among highest and unemployment was low, with few receiving Medi-Cal, Medicare and SSI/SSP.

- ~ Housing was second most expensive in state, with lowest vacancy rates.
- ~ RCFEs more available than home health, NF and adult day services, with few IHSS providers.
